## Elder Boosters Super Split-the-Pot 2018 Terms and Conditions

Elder High School and the Archdiocese of Cincinnati (collectively, "EHS") is sponsoring a Split-the-Pot fundraiser in accordance with the laws of the State of Ohio. The fundraiser shall be known as the "Elder Boosters Super Split-the-Pot" (the "Split-the-Pot"). All proceeds of the Split-the-Pot will go to EHS and will be used in furtherance of its educational, arts, and athletics initiatives to enhance and support the educational experience of Elder High School students. The terms and conditions of the Split-the-Pot are set forth below ("Terms"). The interpretation and application of the Terms by EHS and its legal counsel shall be final. By participating, you agree that:

**ELIGIBILITY:** Participants must be 18 years of age or older. EHS staff, board, committee members, volunteers, and employees are eligible to participate and can win the prize. Participants must qualify under Ohio law. All federal, state, and local laws and regulations apply. VOID WHERE PROHIBITED.

**PRIZE:** The prize shall be fifty percent (50%) of the value of all tickets properly purchased in accordance with these Terms. The value of the prize will depend on the number of tickets sold.

All purchases of tickets are non-refundable (except at the discretion of EHS in the event of ineligibility). NO TICKET ORDERS WILL BE ACCEPTED BY VOICEMAIL OR EMAIL. Tickets will not be sold after the dates and times described above, per method of entry.

EHS reserves the right to reject any ticket that is submitted with payment that does not constitute "good funds" or that is otherwise noncompliant with the Terms.

Please Note: The mailing and email addresses provided on the tickets shall be considered as the addresses for all future correspondence between EHS and you. If either of these addresses changes, it is your responsibility to inform EHS of such change, via the Administrator. DRAWINGS: Each ticket has a separate and equal chance of winning. The drawing of the winning ticket will occur on May 15, 2018 at approximately 12:00 pm (ET) ("Draw Date") at Elder High School, located at 3900 Vincent Avenue, Cincinnati, OH 45205. One ticket will be selected at random by a representative of EHS in accordance with Ohio law and these Terms. The first ticket selected that meets the requirements as set forth in these Terms ("Winning Ticket") will win the prize. The prize will be awarded to the individual whose name appears on the Winning Ticket (the "Winner"). A purchaser of the Winning Ticket will not be deemed to be the winner unless his or her name appears on the Winning Ticket. If the name of more than one person is submitted on the Winning Ticket, then the first name listed shall be deemed the Winner.
